## GWBAA to Hold Third Annual Safety Standdown on Thursday, May 7

GWBAA will hold its Third Annual Safety Standdown on May 7 at the National Transportation Safety Board (NTSB) Training Center in Ashburn, VA. **Captain Alfred C. Haynes,** of United Airlines flight 232, will be the keynote speaker. It was twenty years ago this year that Captain Haynes and his crew, against all odds, crash landed a United DC-10 into Sioux City, Iowa with no hydraulics; there were 184 survivors.

Captain Haynes' presentation is not just for pilots, but for flight attendants, maintenance personal, dispatchers, air traffic controllers, emergency crews, and others. His 75 minute presentation will captivate, inspire, and motive you.

After his address, Captain Haynes will participate in a Q&A and sign books.

# GUEST VIEWPOINT: The Audacity of a Private Jet

David R. Allen, President of the Florida Aviation Trades Association, recently sent an open letter to President Obama in response to recent efforts to vilify business aviation. GWBAA reproduces his remarks below, which we believe represent the views of many in the industry.

#### Dear President Obama:

"Do we participate in a politics of cynicism or a politics of hope?" Those were your words as you answered a question about the book you wrote, "The Audacity of Hope."

I would like to talk about the **Audacity of Owning a Private Jet** and ask for your support for this institution we call aviation. Yes, it is more than an industry; it is an institution that is rooted in history and victories not only in war but also in personal dreams. Dreams of young boys and girls who look up in the sky with anticipation of becoming a pilot or astronaut and of entrepreneurs who wish to reach new heights.



Are all private aircraft owners the same? No! Unfortunately your cynical remark of CEO's and private jet owners in the same sentence during your address has negatively impacted many private aircraft owners and the many businesses that support aviation. Behind every airplane is a manufacturer, a flight instructor, a pilot, a mechanic, a community airport, a Fixed Base Operator (FBO) that services the aircraft, a caterer, an aircraft cleaner, a municipality, an insurance company, a flight training company, and a university to name a few. There are many of us whose livelihoods are at stake.

I would like to also point out that **NONE** of the American aircraft manufacturers received any TARP money but had to lay off thousands of employees in response to this economic downturn and the negative stigma attached to private aviation. Americans who can afford NOT to participate in the recession are now being forced to cut back, because spending in this difficult time has been labeled as irresponsible. Furthermore, private aviation supports many charitable causes such as Angel Flight, which arranges transportation of those people who are financially distressed, or who are in a time-critical, non-emergency situation due to their medical condition.

Are there corrupt, irresponsible, self-serving and inept business leaders? Absolutely! However, I remind you that there is failure in every role in life including politicians, doctors, teachers, police officers, clergy as well as mothers and fathers. But for every abuse we can count thousands of unsung heroes who do the right thing day in and day out unceremoniously.

There are two types of failures; one is done with malicious or hurtful intent and the other is a byproduct of progress. One truth remains about failure. Without failure, there is no progress. Without progress there is no success and without hope there is no future progress or success.

However, if we keep saying it's going to get worse before it gets better it will. You, Mr. President, have the power to change that with your words.

Who could argue with Norman Vincent Peale the great author who wrote "The Power of Positive Thinking?" He said, "Attitude is more important than facts. "The fact is that we are in a mess but the attitude of the American spirit cannot be denied.

Mr. President, I am respectfully asking that you not bring down an entire institution, an entire industry, with your remarks; I am asking that you apologize for those remarks and more importantly I am asking you to give America **HOPE** as you did in your campaign.

I would like to point out the comments of another author who said, "When you focus on solving problems instead of scoring political points, and emphasize common sense over ideology, you'd be surprised what can be accomplished."



You scored a political point during your address at the expense of the diligent, hard working people who proudly serve aviation and the business leaders who provide thousands of jobs in the aviation and related industries.

This same author said:

## **Regional News Round-Up**

On March 17, the Board of Supervisors of Stafford County voted 5-2 to lower the personal property tax on aircraft from \$3 per \$100 of assessed value to 10¢. According to representatives of **Stafford Regional Airport**, the reduction is critical to attract aircraft since the taxes for aircraft based at other regional airports are even lower; the rate at Manassas is 1¢. County data indicates that, in 2008, 46 aircraft were based in



Stafford and collectively were assessed \$84,369.30 in personal property taxes. Stafford Regional Airport Authority Chairman Walt George told the Fredericksburg Free Lance-Star that "[o]ur underlying concern is that it may take two to three years to reinvigorate business interest in the airport. But I feel good about the rate. It is a positive step in the right direction."

A forum was held in advance of the start of a runway expansion project at **Charlottesville-Albemarle Airport**. According to media reports, Bill Pahuta, airport director stated that: "We have a considerable amount of fill that needs to be put into this project. But the first phase is just to prep it and get it ready, clearing and the area designed for the project." The initial phase is expected to take six to eight months.

**BWI Thurgood Marshall Airport** has received a \$15 million grant to reconstruct two aprons at the airport. The Airport Improvement Program grant will be used to improve aprons C and D as well as for markings, airport signs and lights, drainage improvements and the installation of a new deicing collection system.

A Cirrus SR22 crashed shortly after departing **Montgomery County Airpark** on March 15; the airframe parachute was deployed, and the pilot reportedly was not injured. Another Cirrus, landing at **Bay Bridge Airport**, hit a deer while landing on March 25; again, the pilot reportedly was not injured. As always, fly safely!
