Regional News Round-Up

The engineering firm that recently reconstructed the runway at **Winchester Regional Airport** will receive an award from the American Council of Engineering Companies. Delta Airport Consultants, Inc. recycled a substantial amount of demolished pavement. "This sustainable design practice contributed to cost savings through reduced use of virgin materials and reduced impacts associated with hauling and disposal," according to an ACEC press release.



On November 21, Manassas Regional Airport officially opened its extended 6,200 foot runway. A few days earlier, a Metropolitan Aviation Hawker 800XP was the first aircraft to take-off and land on the runway, with Manassas Mayor Hal Parrish II (himself a pilot) on board. The runway is expected to provide for increased safety; reduced noise in the area to the north of the airport; and allow aircraft to operate with full fuel/passenger loads during hot weather.

Effective March 1, 2013, Melinda Crawford will be the new Executive Director of **Charlottesville Albemarle Airport**. She currently is the Director of Pensacola Florida International Airport.

Leesburg Executive Airport recently started publishing a monthly newsletter. Recent news includes that construction for the helipad/north access road project is expected to begin shortly, as well as that Leesburg-based Aviation Adventures received awards at AOPA's October 2012 flight training summit, which was held in California.
