Post-Inauguration TFR Refresher

Temporary Flight Restrictions Don't Happen Just Every Four Years

Although the Presidential Inauguration is now past, the need to be alert to Temporary Flight Restrictions (TFRs) is a continuing concern for pilots, especially in the greater Washington area. TFRs are airspace restrictions instituted due to special circumstances or events such as government VIP movement, sporting events, natural disasters, etc. An FAA primer about TFRs can be found at <u>http://www.faa.gov/pilots/safety/notams_tfr/media/tfrweb.pdf</u>, and a list of current TFRs and related information is maintained at <u>http://tfr.faa.gov</u>.

The purpose of TFRs is to secure airspace, but the economic ripple effect of a TFR is also a matter of concern to the business aviation community. Airports that fall within a TFR can suffer significant revenue losses due to the lack of operations. In the case of last weekend, all GA operations at DCA were prohibited for eight hours during the events on the 21st – although GA operations at DCA are heavily restricted pursuant to the DCA Access Standard Security Program (DASSP), they do exist with the support of the Signature Flight Support FBO.

GWBAA and the general aviation community as a whole understands the importance of TFRs and security measures. Representatives of general aviation such as NBAA, NATA, and GAMA continue to request that FAA and other agencies work with us to develop procedures that meet security standards while not restricting commerce. It is important for government and industry to work together to ensure security without unjustifiably restricting an industry that stimulates the U.S. economy.

Regional News Round-Up

Leesburg Executive Airport has announced that repaving of the north hangar access road is expected to begin in the spring. Construction also is continuing on two new helipads adjacent to the south apron; one will be dedicated to air ambulance operations, while the other will be available to all users.

In December, a runway expansion project was officially completed at **Charlottesville-Albemarle Airport**; the runway as extended by 800 feet, to a total of 6,801 feet.



On December 17, the Louisa County Board of Supervisors passed a resolution honoring Rear Admiral DeWitt Freeman – the namesake of the county's airport, **Freeman Field** – who passed away in November. Airport Manager Dawn Howard told the *Central Virginian* that: "He loved that airport. It was his passion in life."
