FAA General Aviation News



The current issue of the FAA's general aviation newsletter is now available at http://www.faa.gov/news/safety_briefing/2014/media/JulAug2014.pdf. The topic of the issue is a "Flying Companion's Guide to GA" - i.e., about introducing friends and family to flight, and the role of passengers aboard general aviation aircraft. The article include a general introduction entitled "Fighting the Fear, Finding the Fun"; a guide to aviation lexicon; a discussion of partnering with pilots for safety and risk management; and an explanation of aircraft weight and balance issues.

Regional News Round-Up

Effective June 9, Runway 15R-33L at **Baltimore/Washington Thurgood Marshall Airport** has been closed for a 90-day reconstruction project. No impact is expected on operations/ most air carrier operations will instead use Runway 10-28.



Construction is continuing at **Manassas Regional Airport** to widen existing runway and taxiway bridge structures to meet FAA safety requirements. The current phase of work is expected to be completed in November; until then, nighttime closures of Runway 16L/34R will be routine (check

NOTAMS for details). For more information about the project, please visit <http://manassasbridgeextension.com>.

The FAA reportedly is considering if car races can be allowed at **Greater Cumberland Regional Airport**; typically the FAA limits the use of temporary partial closures for non-aeronautical events at airports. The FAA also is studying proposals for the removal of trees and other obstructions near **Crisfield-Somerset County Airport**.



The Stafford Regional Airport Authority and the Stafford Economic Development Authority have announced plans for a land swap to create a larger "buffer zone" around **Stafford Regional Airport**. The airport will acquire 104 acres to the northwest of the airport, in return for 15 acres on the southern edge of the airport (which are worth about the same amount, due to their proximity to U.S. 1). Additionally, the Stafford County Planning Commission recently recommended that plans for a residential development named "Oakenwold" be denied due to its proximity to the airport, but the Board of Supervisors is yet to make a final decision. In other Stafford news, the Aviation Adventures flight school earlier this month opened a new location - its fourth - at the airport.

Warren County is considering eminent domain as an option to acquire easements/property upon which there are trees that interfere with approaches to **Front Royal-Warren County Airport**, as well for the construction of FAA-mandated beacons. County Attorney Blair Mitchell told the *Northern Virginia Daily* that the county has reached deals with most of the needed property owners, but there are two hold outs.
