NBAA Expresses Concerns About FAA Reauthorization


Congressional Bill May Privatize ATC and Make Other Changes of Concern to GA

The FAA typically is funded on a multi-year basis, and the next FAA funding bill is due to be enacted by Congress later this year. In connection with this "reauthorization" process, Congressman Bill Schuster (R-PA) -Chair of the House Transportation and Infrastructure Committee - is expected to propose the privatization of the FAA's air traffic control responsibilities. The NBAA is concerned that this and other elements of his reauthorization bill may have negative consequences for general and business aviation, including by stripping Congress of its oversight responsibilities; imposing new user fees - possibly on a per-flight basis; and creating a self-interested/appointed board to make funding and access decisions.
