## Regional News Round-Up

The NTSB has released its final report on the December 8, 2014 accident near **Montgomery County Airpark** which resulted in the deaths of six (three aboard the aircraft and three on the ground). **Louisa County Airport** has been upgraded to regional airport status by the Virginia Department of Aviation. "The ultimate goal is to have this airfield support the local economy with jobs," Airport Manager Virgil Hill stated in comments on the news. New runway and security lightning recently have been installed, and the airport plans to lengthen its runway from 4,300 feet to 5,500 feet.

On May 24, an accident in Orange County resulted in the death of both the pilot and passenger aboard the Kappa KP-5; the latter was John Joseph Quinn Jr., a flight instructor and hangar owner at **Culpeper Regional Airport**. On June 6, an experimental aircraft crashed at **Stafford Regional Airport**; no serious injuries were reported. As always, fly safely!
