On July 20, over 30 GWBAA members traveled to ARINC's headquarters in Annapolis for a lunch outing that included a very interesting briefing about the company, which is a leader in transportation communications and systems engineering. ARINC develops and operates communications and information processing systems and provides systems engineering and integration solutions to five key industries: airports, aviation, defense, government, and surface transportation. Founded in 1929 to provide reliable and efficient radio communications for the airlines, the company today calls Annapolis home, and operates regional offices in London and Singapore, with over 3,200 employees worldwide.

Security Reminders for General Aviation from TSA:

In the past week, public attention focused on the additional security requirements that TSA adopted for commercial passengers in the wake of widespread arrests of alleged terror plotters in the U.K. But TSA also released a notice to charter, air cargo, corporate, and general aviation operators, asking them to also be alert to any suspicious activity involving the use of liquids or gels, and to review their overall security procedures. • Regional News Roundup:

Leesburg Executive Airport has a new Director: Tim Deike has accepted the position and was recently welcomed to GWBAA by President Bob Blouin. Tim most recently came from Hickory, North Carolina and brings great experience to his new and challenging position. We look forward to seeing Tim at up-coming GWBAA events.



In other Leesburg Executive Airport news, Leesburg and Loudoun County planning commissioners were publicly at odds during a joint meeting in July to discuss plans for a proposed development west of the airport. The airport itself has opposed the development, **Crosstrail**, because it would interfere with the traffic pattern and/or generate noise complaints, but supporters of the development argue that these claims lack foundation. At the same time, Leesburg and Loudoun commissioners accused each other of being uncooperative; the airport itself is within the town's jurisdiction but the planned development falls within the county's jurisdiction. Notably, Loudoun County's representatives stated that the town did not appear to be aware of the status of the airport's master plan, despite its relevance to the meeting, and had not discussed potential land purchases by the town to protect the airport. Meanwhile, Leesburg representatives alleged that they had been excluded from the county's planning process.

Construction crews at **Hagerstown Regional Airport** currently are laying support beams for the runway bridge that will span across Route 11. According to Airport Manager Carolyn Motz, the bridge is phase three of a \$61 million runway improvement program, which will both increase the length of the runway and meet FAA safety area requirements. The project, funded in part with \$47 million from the federal government, is expected to be completed at the end of 2007.



Paul G. Anderson, Jr. was selected to serve as chairman of the **Winchester Regional Airport Authority**, a position that he previously held in the 1990s. In other Winchester-related news, the Authority is reviewing two bids for the construction at the airport of a wash rack for aircraft, and the Frederick County Board of Supervisors approved a memorandum of understanding to provide \$120,000 to secure a location at the airport for ProJet Aircraft Service's management and operational aircraft facility. Additionally, a FAA spokeswoman recently stated that even though the FBI plans to open a records complex in Frederick County in 2010, there are no plans to expand the Greater Washington area ADIZ to cover the facility.



An advisory committee has selected an architect to design a new terminal at **Culpeper Regional Airport**. Subject to approval by the County Board, the architect will be Studio Ammons of Petersburg, Virginia, and Paris and Campbell Engineers of Blacksburg, Virginia will manage the project. The terminal is expected to cost about \$1.4 million, with 95% of the funding coming from the federal and state governments. Construction is estimated to start in August or September 2007.

A Montgomery County resident, Bob Gillespie, has filed an application with the FAA and Maryland Aviation Administration to operate a private airstrip in Montgomery County. Even though the strip lies within the northern boundary of the Greater Washington area ADIZ, Gillespie has received preliminary approval from the FAA for the strip, dubbed **Fly Away Farm**. The use of the airfield, which technically would be an agricultural strip, would be limited to daylight hours and could only be used by Gillespie's own airplane absent additional approvals.
