• Want to Support Corporate Aircraft Response in Emergencies ("CARE")?

A recently formed group called "CARE" has been established to provide air support to victims of national emergencies. This group includes members of the aviation community who believe that business aviation can act as a first responder in crises. CARE's mission is to provide immediate



air support to victims when the scope of an event merits private-sector intervention. CARE is working with Angel Flight America as well as NBAA, through its Schedulers & Dispatchers Committee, to devise a way to establish a rapid-response team of business aircraft operators. • Jack Olcott to Be Honored With NAA Elder Statesman Award:

John W. Olcott, who served as NBAA's president from 1992 to 2003, will be honored with a 2006 National Aeronautical Association ("NAA") Elder Statesman of Aviation Award at a dinner on November 6. Olcott, the founder and president of General Aero, also has served as editor of Flying magazine, editor and publisher of Business and Commercial Aviation magazine, and president of the New Jersey Aviation Association. He has been a respected figure in aviation for more than 40 years and was educated as an aeronautical engineer. Now a resident of Morristown, New Jersey, he is the recipient of numerous aviation and publishing honors. He holds an airline transport pilot license and several type ratings, and has more than 7,000 hours of flying time. "I can't think of a better, more deserving recipient of this award," said GWBAA President Bob Blouin. "Jack has made many contributions to business aviation, always emphasizing safety, security, and access when framing our industry. • ADIZ Update:

Readers of GWBAA News will recall that FAA solicited comments at the end of 2005 on its plan to make the Washington, D.C. Air Defense Identification Zone ("ADIZ") permanent. GWBAA's president, Bob Blouin, submitted oral and written comments seeking better dialogue between the government and civilian stakeholders. Although FAA has not yet publicly responded to any of the comments, last month they did agree to attend a meeting organized by Senator James Inhofe (R-Oklahoma) with other interested parties, including the Secret Service, Department of Homeland Security, and Department of Defense. Inhofe – who is a pilot and member of AOPA – chided FAA for failing to submit congressionally mandated reports justifying the ADIZ and recommending operational improvements. The meeting's attendees included AOPA President Phil Boyer, who renewed AOPA's recommendation of corridors using specific transponder codes for specific airports within the ADIZ. "It was good to have people on both sides talking in the room and even better to have some get a talking-to from U.S. senators," said Boyer.

In other ADIZ-related news, the Coast Guard has assumed responsibility from Customs and Border Patrol for intercepting aircraft that enter the ADIZ without the proper flight plan and clearance. Coast Guard will use HH-65C Dolphin helicopters stationed at Reagan National Airport. The helicopters are equipped with civilian-frequency VHF radios plus electronic signboards so that they can communicate with pilots who might be having radio problems. Coast Guard at DCA also operates a Gulfstream and a Challenger in support of the office of the Commandant. The Coast Guard's DCA Air Station is a member of GWBAA.



• <u>9/11 Compensation for D.C.-Area GA Operators:</u>

DOT has requested comments on a proposed rule that would allocate \$17 million among fixedbased general aviation operators and providers of general aviation ground support services in the greater Washington area for the financial losses they incurred while five airports were closed, or GA operations were limited, in the aftermath of the September 11, 2001 attacks. The affected airports are Reagan Washington National, Colle Park; Potomac Airfield; Washington Executive/Hyde Field; and the South Capitol Street Heliport. The proposed rule would establish eligibility requirements and application procedures for the funds, which were allocated by Congress in 2005; DOT has requested that comments be filed by November 3, 2006. <u>Regional News Roundup:</u>

Landmark Aviation has named Jim McNeill its new regional vice president, FBO Operations. McNeill has been general manager at Landmark Aviation's flagship facility at **Washington Dulles Airport** and now will manage several key FBOs in Landmark's network. This will include



Leesburg Executive Airport; Toronto, Ontario; Fayetteville, North Carolina; and Raleigh-Durham, North Carolina. He also will continue to manage the Dulles FBO until his successor is named. McNeill has been the general manager at Dulles since 2003.



The Loudoun County Planning Commission recommended in September that the county approve the construction of a mixed-use development south of Leesburg Executive Airport. The "Crosstrail" development has been opposed by the Leesburg Town Council and Leesburg Airport Commission, which believe that noise complaints could hurt the airport's viability. But the property to be developed falls within the jurisdiction of Loudoun County, despite its proximity to the airport. A public hearing will be held by the county on the development in November.

The Flight Deck Restaurant, which had been located at NextFlight's facility at **Manassas Regional Airport,** closed its doors in early September.

A number of Carroll County residents expressed their concerns about expansion plans for **Carroll County Regional Airport** at a public meeting last month. The meeting was held to solicit comments on the airport's master plan, a draft of which is due to be completed by the end of the year. The airport plans to invest \$60 million in improvements, including a 1,400-foot runway extension and hangar construction. The public comments included concerns about the airport's security; in response, the county noted that \$700,000 has been budgeted this year to purchase a surveillance system.



As readers may recall, the August 2005 issue of GWBAA News reported that a glider club had filed a suit alleging that the closure of a turf runway at **Frederick Municipal Airport** violated the terms of an agreement between the airport and the FAA. A federal court now has dismissed the suit, concluding that the glider club did not have a right to sue under the FAA agreement, and that the airport had not breached any contractual agreements to which the glider club was a party.
