# TSA Announces Policy to Allow DCA Access Standard Security Program (DASSP) Operators Access to Republican Convention Airspace

## TSA Letter Outlines Approval Process for Access to Convention Airspace

Earlier this month TSA issued a letter outlining the approval process for DASSP operators to operate during the upcoming Republication convention in Minneapolis. Below is the letter:

#### Good afternoon!

The Transportation Security Administration (TSA), in conjunction with other federal agency security partners, would like to announce the eligibility of DCA Access Standard Security Program (DASSP) operators to operate in to Temporary Flight Restrictions (TFR) surrounding the Republican National Convention (RNC) in the Minneapolis/St. Paul area September 1-4, 2008. Only current DASSP operators (as of August 1, 2008) will be eligible for this initiative.

(Note: No similar program is necessary for the Democratic National Convention, to be held in Denver, Colorado August 25-28, 2008. The applicable TFRs should have no negative impact on general aviation flights, due to airport location and an allowance made for safe approach and departure from Centennial Airport (APA)).

DASSP operators must follow the existing requirements of the DASSP, including carriage of an armed security officer, screening of crewmembers and passengers, and all other conditions stipulated in the program, with one exception: Flight authorizations, including passenger information, must be submitted 96 hours prior to the intended flight to be permitted access to the RNC TFR. Flight authorizations will be available online next week. A link will be provided to you at that time.

As you can imagine, this sensitive event requires considerable interagency coordination, and we appreciate your assistance in implementing this initiative. TSA has pursued this initiative in an effort to recognize your commitment to security and provide your operation with increased flexibility. FAA NOTAMs 8/1196 and 8/1094 reflect the eligibility of DASSP operators.

## FAA Adopts Special Awareness Training Rules for Washington, DC

The FAA has issued a final rule requiring "special awareness" training for any pilot who files under VFR within a 60-nautical mile radius of Washington, DC effective February 9, 2009. The training will be provided online via <a href="http://www.faasafety.gov">http://www.faasafety.gov</a>, and pilots will be able to print out a certificate of training. The training and will focus on procedures for flying in and around the Air Defense Identification Zone ("ADIZ") and Flight Restricted Zone ("FRZ") and is intended to reduce unauthorized flights into those airspaces. ## **DOT Adopts Proposed Landing Fee Rules, but Few Changes Expected**

DOT has adopted most of the so-called "congestion pricing" rules that it first proposed in January, and solicited public comments (for a copy of the final policy as adopted, please visit <a href="http://www.regulations.gov/fdmspublic/ContentViewer?objectId=0900006480672263&disposition=attachment&contentType=pdf">http://www.regulations.gov/fdmspublic/ContentViewer?objectId=0900006480672263&disposition=attachment&contentType=pdf</a>). Although the proposal was opposed by virtually all general aviation trade groups, including NBAA, as well as other aircraft operators, the DOT found that they were both lawful and necessary. In doing so, however, the DOT acknowledged that they were likely to have limited effect.

The theoretical ability of an airport to impose a landing fee based on both operations and weight first was recognized in the Massport case twenty years ago, although the two-part fee that was at issue in that case was held to be unlawful. The new rule re-states the general principle that airports can assess two-part fees – but at the insistence of NBAA and other interested parties, makes clear that a two-part fee can only be imposed during demonstrably congested hours and must be both justified in detail and discussed with operators before it is imposed.



The other two policies approved by FAA – one that allows work-in-progress to be included in landing fees for congested hours and another that allows the costs of secondary airports under common ownership and control of a congested airport to be included in landing fees for congested hours – also are expected to have little, if any, practical impact.

## **Regional News Roundup**

Several historic farm buildings near **Hagerstown Regional Airport** may be moved, after FAA and TSA expressed concern about their location, 500 feet from the end of the airport's recently-extended runway. Because the farmstead - which includes a late 19th-century brick house, an 18th-century smokehouse an a rare pierced-brick barn - was given historical designation in 2001, federal law requires efforts be made to relocate or otherwise preserve them, rather than demolish them. The Washington County Commissioners are scheduled to discuss the available options, and whether federal funding would be available.

The Albemarle County Supervisors have approved a plan to extend the runway at **Charlottesville-Albemarle Regional Airport**. The current 6,001-foot runway will be extended by 800 feet. The extension is necessary because some aircraft which regularly serve the airport can't land fully loaded during times of high humidity and temperature. The project will require rearranging some neighboring wetlands and runoff areas.



Warren County officials plan to hold a hearing on the removal of trees near **Front Royal-Warren County Airport**. According to Deputy County Administrator Richard J. Magnifico, the trees could become obstructions in the future. In an interview with the Northern Virginia Daily, he said that "[t]he issue is this is something we would like to be proactive rather than reactive." The trees stand along the southerly boundary of the airport. The hearing would also include a



presentation on the airport's 20-year layout plan, which includes plans for the acquisition of additional property.
