Mike Mullane Keynotes GWBAA Safety Standdown

Former Astronaut Warns Against the “Normalization of Deviance”

The sixth annual GWBAA safety standdown was held on May 16 at the NTSB Training Center in Ashburn, VA. The keynote speaker was author and former astronaut **Mike Mullane**, who flew on three space shuttle missions and emphasized the importance of “guarding against a normalization of deviance” based on his experiences in the shuttle program and in the U.S. Air Force. Other speakers included Andreas Bentz of Chantilly Air on OSHA issues; Jim Garland of Sharp Details on “Flight Plan for Excellence”; Shannon Forrest of FlightSafety International on crew resource management; and Cynthia Keegan of the NTSB on TWA 800. Additionally, at the end of the forum, Harry Houckes awarded the NBAA’s Silk Scarf Award to GWBAA President Paige Kroner, for her contributions to the business aviation community.

DCA Access Updates

Despite what you may have heard, Reagan National Airport is **OPEN** to General Aviation! While the activity is not anywhere near the heyday before 9/11, it certainly is moving in the right direction at the FBO, Signature Flight Support.

What's changed?

Last year at this time, the TSA enhanced the DCA Access Standard Security Program (DASSP) to improve access. The changes include:

- flexibility for tail number and crew swaps;
- increased hours of operation;
- prohibited items list is normalized to pre-9/11 levels; and
- increased number of gateway airports – with the most recent addition – Pontiac, Michigan (PTK) – there are now 74 gateways.

Also, did you know:

- DASSP approved operators can fly **crew only** flights without an ASO.
- Once cleared to DCA, operators may land after hours, if staffing is arranged.

FAA Requests BARR Comments

In 2011, Congress required the FAA to restore the Blocked Aircraft Registration Request (BARR) program, which enables aircraft operators upon request to block public dissemination of

information about aircraft movements; the FAA previously had decided, without justification, to severely curtail the program. Now that Congress has required the program to continue, the FAA has requested comments on the information that operators should be required to submit as part of block requests, and the procedural requirements for submitting block requests. Comments are due on June 8, 2012. Regional News Round-Up

The Leesburg Town Council has revised permit program for outside businesses that provide services at **Leesburg Executive Airport**. Deputy Town Manager and Airport Director Kaj Dentler stated that there the airport is served by mobile businesses, such as mechanics and other companies that provide instrument installation and bodywork for aircraft. "We're trying to be more accommodating for businesses who want to come to the airport but aren't physically located at the airport." The fee is \$680 per year or \$100 for a 30-day period.



The Stafford County Board of Supervisors approved a \$1.4 million loan to assist in the construction of a new terminal at **Stafford Regional Airport**. The Virginia Department of Aviation is expected to contribute an additional \$2.2 million. The current terminal is a doublewide trailer. Construction is expected to begin the fall, and be completed in the summer of 2014.

The new control tower at **Frederick Municipal Airport** began operations on May 1; its operational hours are 7am-9pm. Airport Manager Kevin Daugherty told the *Frederick News-Post* that the \$5.3 million project could help bring extra business to the city, as well as enhance safety; Frederick is the second-busiest GA airport in Maryland. "It's nice having an eye in the sky."

The Warren County Planning Commission has approved the construction of a new weather observation station at **Front Royal-Warren County Airport**. Design and construction will be funded by the Virginia Department of Aviation. Construction is expected to begin the fall.
