

## **Regional News Round-Up**



Baltimore Helicopter Services, the owner of **Pier 7 Heliport** in Baltimore's Inner Harbor, has received TSA approval to serve as a gateway for flights to Reagan Washington National Airport under the TSA's Fixed Base Operator Standard Security Program (which allows for pre-cleared operators to undergo the security screening necessary to fly to DCA). Pier 7 is the first heliport to receive such an approval.

The **Stafford Regional Airport Authority** held a meeting to discuss building standards for two prospective tenants, each of which would erect 10,000 square-foot buildings. The identity of the tenants has not been disclosed, because negotiations are ongoing. In other news, the authority expressed concern that a developer was seeking to rezone property near the airport in order to build up to 700 homes in a neighborhood that it would call "Oakenwald." The Stafford County Sun reported that authority member Charles "Lindy" Kirkland stated that: "It will be the bane of our existence. We need to oppose it vehemently."

MAG, Inc., an aircraft repair facility at **Hagerstown Regional Airport**, announced that it had received FAA approval to conduct advanced maintenance work on AW139 helicopters. MAG received incentives from Washington County to set up shop in Hagerstown, which will require MAG to maintain 18 full-time employees for a five-year period.
